EXPRESSION OF INTEREST (EOI)

Sealed Expressions of Interest (EOI) are invited from Government accredited PMC having proven expertise in the field of electrical infrastructure projects for the upgradation of existing LT Power Supply to HT Power Supply also supply, installation, testing and commissioning of 315kVA Transformer and include provision for DG of 250kVA set at Muttathara RDF Plant, Clean Kerala Company Limited, Thiruvananthapuram, Kerala.

Scope of Work

The selected PMC shall be responsible for, but not limited to, the following:

1. Conversion of the existing power supply arrangement from two independent LT connections to a single HT connection from KSEB Ltd.
2. Conduct site inspection and prepare load calculation details considering future expansion.
3. Feasibility study and recommendations.
4. Preparation of electrical scheme, technical drawings and specifications.
5. Undertake procurement of 315kVA Transformer and Ring main Unit (RMU) including testing, installation, and commissioning.
6. Include provisions for the connection of a Diesel Generator (DG) system.
7. Prepare cost estimates using Price Software rates and submit the Bill of Quantities (BOQ).
8. Obtaining necessary statutory approvals and clearances from KSEB, Electrical Inspectorate, Pollution Control Board and other competent authorities as applicable. (Note: KSEB deposit for HT connection is in CKCL scope).
9. Preparation of completion reports.

Eligibility Criteria

Interested PMCs shall satisfy the following minimum eligibility criteria:

- Must be a Government-accredited PMC
- Have a minimum of 5 years' experience in electrical project management consultancy services.
- Have successfully executed at least three similar electrical infrastructure projects involving HT power systems, transformers, and DG set.
- Possess adequate technical expertise, manpower and infrastructure.
- Have valid statutory registrations including GST, PAN and other applicable licenses.
- Demonstrate sound financial capability and organizational strength.

Interested parties shall submit their EOI in a sealed cover superscribed: "EOI for Electrical works at Muttathara RDF Plant, Thiruvananthapuram, Kerala".

The EOI shall contain:

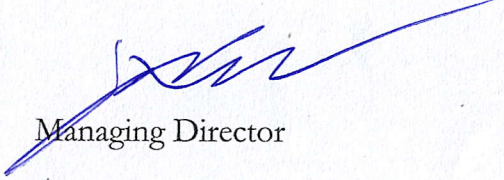
