



EXPRESSION OF INTEREST (EOI)

Inviting Expression of Interest (EOI) for Collection, Segregation, Transportation, Sale of Recyclable Waste and Processing of Non-Recyclable Plastic Waste at Sabarimala Sannidhanam and Pamba

Clean Kerala Company Limited (CKCL), a Government of Kerala Undertaking under the Local Self Government Department (LSGD), invites Expressions of Interest (EOI) from experienced waste management agencies, recyclers, scrap processors, and authorized firms for undertaking the collection, segregation, cutting (where required), transportation, sale of recyclable waste materials, and processing of non-recyclable plastic waste generated at Sabarimala Sannidhanam and Pamba.

1. Scope of Work

The successful agency shall undertake the following activities:

1. Collection of recyclable and non-recyclable waste from the designated locations at Sabarimala Sannidhanam and Pamba.
2. Segregation of the collected waste into the specified categories.
3. Cutting, dismantling, or size reduction of materials wherever required to facilitate handling and transportation from Sannidhanam to Pamba.
4. Loading, shifting, and transportation of the segregated materials from Sabarimala Sannidhanam to Pamba using the tractor arrangements provided for the purpose.
5. Weighment of all collected materials at the designated weighbridge at Pamba.
6. Maintenance of category-wise weighment records and submission of weighment details to CKCL.
7. Sale of recyclable materials through transparent and legally compliant procedures.
8. Processing and environmentally sound disposal of non-recyclable plastic waste through authorized facilities in accordance with the applicable environmental regulations.
9. Compliance with all applicable labour laws, environmental regulations, safety standards, and statutory requirements during the execution of the work.

2. Estimated Quantity

The estimated quantity of waste to be handled under this EOI is **more than 100 Metric Tonnes (100 MT)**.

The quantity indicated is only an estimate based on the expected waste generation at Sabarimala Sannidhanam and Pamba.

3. Waste Categories and Financial Quote

A. Recyclable Waste Categories

Interested agencies shall quote the purchase rate (₹ per kg) payable to Clean Kerala Company Limited (CKCL) for the following recyclable waste categories at Sannidhanam and Pamba.

The quoted rate shall represent the **net amount (Excluding GST) payable to CKCL** after considering all costs involved in collection, segregation, cutting, loading, handling, tractor transportation, labour, and other incidental expenses.

B. Non-Recyclable Plastic Waste (Rejects for cement factory)

Interested agencies shall separately quote the **processing charge (₹ per kg)** payable by CKCL for processing and environmentally sound disposal of non-recyclable plastic waste at sannidhanam and Pamba,

The quoted processing charge shall include collection, segregation, handling, cutting (where required), loading, tractor transportation, processing, and environmentally sound disposal through authorized facilities.

4. Weighment and Documentation

All waste materials shifted from Sabarimala Sannidhanam and Pamba shall be weighed at the designated **Pamba Weighbridge**.

The successful agency shall:

- Ensure accurate weighment of every consignment.
- Maintain category-wise weighment records.
- Submit weighbridge slips and weighment details, including date, vehicle details, waste category, and quantity, to CKCL.
- Maintain proper documentation for verification, billing, accounting, and revenue reconciliation.

The weighbridge records shall be treated as the final record for quantity verification.

CKCL reserves the right to inspect, verify, and audit the records at any stage during the execution of the work.

5. Basis of Quotation

The rates quoted by the bidder shall be **inclusive of all costs** associated with the execution of the work, including:

- Collection and segregation.
- Cutting, dismantling, or size reduction of materials, wherever required.
- Loading and unloading.

- Labour charges.
- Tools and equipment.
- Packing and handling.
- Internal shifting from Sabarimala Sannidhanam to Pamba through the available tractor transportation arrangement.
- Administrative overheads and incidental expenses.

No additional payment or claim shall be admissible over and above the accepted rates.

6. Time Schedule

The entire assignment shall be completed **within 30 days** from the date of issue of the Work Order. No further extension allowed.

7. Eligibility Criteria

Interested agencies shall satisfy the following minimum eligibility requirements:

- The bidder shall have a **minimum of five (5) years of experience** in waste management, plastic waste recycling, scrap processing, solid waste management, **or similar activities**.
- Possess valid GST Registration and other statutory registrations applicable to the nature of work.
- Comply with all applicable labour laws, environmental regulations, and safety requirements.
- Have adequate manpower, equipment, and financial capability to execute the work satisfactorily.

Documentary evidence shall be enclosed.

8. Evaluation of EOI

The EOI applications shall be evaluated by CKCL based on:

- Technical capability.
- Experience in similar works.
- Availability of manpower and equipment.
- Statutory compliance.
- Financial proposal/quotation.

CKCL reserves the right to accept or reject any or all applications without assigning any reason.

9. General Conditions

1. CKCL reserves the right to modify, cancel, postpone, or withdraw this EOI at any stage without assigning any reason.
 2. The successful agency shall strictly comply with the directions issued by CKCL and the Travancore Devaswom Board during the execution of the work.
 3. The agency shall be solely responsible for the safety of its personnel, equipment and materials during the execution of the work.
 4. All applicable taxes, duties, statutory liabilities, insurance, and compliance requirements shall be the responsibility of the successful agency.
 5. The quantities indicated are tentative and may vary depending on the actual waste generation.
 6. The successful agency shall ensure that all recyclable materials are handled transparently and that non-recyclable plastic waste is processed only through authorized facilities in compliance with applicable environmental regulations.
 7. The successful agency shall not sublet or assign the work, either wholly or partly, without the prior written approval of CKCL.
 8. **Earnest Money Deposit (EMD):** The selected agency shall remit an Earnest Money Deposit (EMD) before the execution of the Agreement. The EMD amount shall be determined by Clean Kerala Company Limited (CKCL) at the time of execution of the Agreement, based on the category of scrap, estimated quantity/weight, and the assessed value of the scrap.
