Expression of Interest (EOI) for the Supply, Installation, Testing and Commissioning of Plastic Recycling Machinery at IPWMF, Kunnammthanam, Pathanamthitta

1. Introduction

Clean Kerala Company Limited (CKCL), a Government of Kerala undertaking, invites Expressions of Interest (EOI) from eligible manufacturers, authorized dealers, and suppliers for the **Supply, Installation, Testing and Commissioning** of plastic recycling machinery for the Integrated Plastic Waste Management Facility (IPWMF) at Kunnammthanam, Pathanamthitta, Kerala.

2. Scope of Work

The scope of work includes the supply, installation, testing, commissioning, training, and warranty support for the following machinery:

3.General Technical Requirements

1. All equipment shall be new, unused, and of the latest design.
2. The successful bidder shall supply, install, test, and commission the machines at the designated project site.
3. The bidder shall provide all standard accessories, electrical panels, cables, safety guards, and other items necessary for complete operation.
4. The equipment shall be suitable for continuous industrial operation under normal working conditions.
5. Operation and maintenance manuals shall be supplied in English at the time of delivery.
6. The supplier shall provide on-site training to the operating personnel during commissioning.

7. A minimum warranty of 12 months from the date of commissioning shall be provided against manufacturing defects. In addition, the supplier shall provide comprehensive after-sales service support.
8. The quoted specifications are minimum requirements. Bidders may offer higher specifications without additional cost.

4. Eligibility Criteria

- Manufacturers or authorized dealers/distributors of the proposed machinery.
- Experience in supplying and commissioning similar plastic recycling machinery.
- Valid GST Registration.
- The bidder shall possess the necessary technical capability and after-sales service support.

5. Delivery Location

6. Price Basis

The quoted price shall be on F.O.R. (Free on Road) Destination Basis and shall be inclusive of packing, forwarding, loading, transportation, unloading, transit insurance, and all other incidental charges up to the above delivery location. No additional charges towards transportation or delivery shall be entertained by Clean Kerala Company Limited.

7. Time Schedule

The entire supply shall be completed **within Fifteen (15) days** from the date of issue of the Purchase Order.

8. Payment Terms

1. 50% of the total Purchase Order value shall be released as an advance payment against submission of the Proforma Invoice and acceptance of the Purchase Order.
2. The balance 50% shall be released after the successful delivery, installation, testing, commissioning, and acceptance of the machines at the designated site, upon submission of the following:
 - o Original Tax Invoice.
 - o Delivery Challan.
 - o Installation and Commissioning Report duly certified by the authorized representative of Clean Kerala Company Limited.

- Warranty Certificate.
 - Any other documents, if required under the Purchase Order.
3. All payments shall be subject to statutory deductions, if any, as applicable under the prevailing laws.

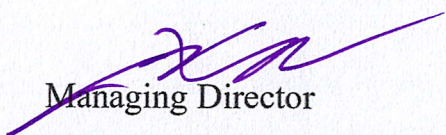
