1. Introduction

Obtain the Fire No Objection Certificate (Fire NOC) from the competent authority and hand over the original approval along with all approved drawings and documents to CKCL.

3. Eligibility Criteria

Interested agencies shall satisfy the following minimum eligibility requirements:

A. Experience

- Minimum **5 years** of experience in Fire & Safety consultancy and project implementation.
- Experience in Government projects is mandatory.

- Experience in Industrial Buildings, Processing Plants, Factories, Waste Management Facilities, Public Buildings, CPWD/PWD Projects or similar infrastructure projects.

B. Contractor Registration

The applicant shall be:

- Registered with CPWD/PWD or any Government Department.

C. Financial Criteria

- Minimum Annual Turnover of **₹4 Crore** during the last Financial Year.

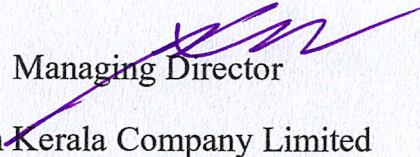
